#### Notes and rules for vehicle entries

1. The closing date for entries to be included in the programme will be 10<sup>th</sup> July 2023, provided maximum entries have not been reached and available space taken up before that date. Any entries after this date may not feature in the programme. Late entries can be accepted until close of play on 12<sup>th</sup> July 2023.

2. Final instructions will be sent to all entries by the Events team in advance of the event, including times for entering the site and any other arrangements.

3. No vehicle (entrant or otherwise) will be admitted to the site after the event has opened to the public. This rule will be strictly adhered to and unfortunately all late arrivals regardless of reason will be asked to park in the car park.

5. No gratuities or expenses will be paid to entrants.

6. One museum entry ticket will be provided to the entrant free of charge which will allow them access to the museum on the day of the event only. Entry to the event is free for the entrant however any other accompanying individuals must pay entry to the event unless agreed by exception with the Events team.

#### **Steam Engines**

The following rules will apply to steam engines on site:

7.1 When in operation, a steam engine must be attended at all times by either the entrant or a suitably trained and responsible person delegated by the entrant.

7.2 The museum team will provide sufficient space within the grounds to ensure that a reasonable distance is available between the engines, it is the responsibility of each entrant to ensure that no person can approach beyond a safe distance their engine whether it is operating or not.

7.3 The only people permitted within the steam engine space are the entrants or in the absence of any entrant one responsible person acting on their behalf, the Events team, museum leadership team and/or the stationary engine judge.

8. All steam engines must be in test, with the appropriate insurance for the event (i.e. public liability) and copies of all insurance documents must be provided to the Events team on request.

#### **Insurance Requirements**

9.1 It is the responsibility of all persons whether they are named entrants or not to ensure that prior to driving any vehicle anywhere on site that the driver is comprehensively insured.

9.2 It is the responsibility of the entrant to ensure the Events team have copies of all insurance documents required to participate in the event. For example, a cover letter from your insurer stating that you are insured to participate in a parade or for track day use. No person shall be permitted to drive without showing these documents.

9.3 No person shall drive any vehicle within the site without being the holder of a Driving Licence covering the type of vehicle to be driven.

9.4 No person shall be carried anywhere within the site on any vehicle which is not constructed or adapted to carry passengers. For the avoidance of doubt dual seat tractors do not constitute a passenger carrying vehicle and should be used solely by the driver.

9.5 During the event no vehicle shall be driven from the vehicle compound except where its movement is coordinated with the marshals.
